Oct. 2015 Session) and in view of the postponement of ATPL Oral examination . Oct. 2015 session, to facilitate only those ATPLG / ATPCG candidates who are scheduled to appear in Oct. 2015 Oral Examination, the application portal (for ATPLG / ATPCG General Papers including application for Oral examination) will remain open till 4<sup>th</sup> Jan 2016.
